## AVERAGES

(1) An entrant uses his tournament average from the last 2 PCDBA tournaments or his highest 2022-23 USBC Certified Book average or 45 or more games, whichever is the highest average.
(2) If his current (2022-2023) average of 21 or more games as of FEBRURARY 1, 2024 is 10 pins higher than 2022-2023, his current February 1, 2024, average shall be used, but if PCDBA tournament average is 10 pins or higher than either of those, PCDBA tournament average shall be used.
(3) If no 2021-22 average, he shall use his current average. He shall provide a copy of the league sheet showing 21 games before May 10, 2024.

## HANDICAP

220 Scratch; $100 \%$ of difference; 80 pins maximum per game (240 pins per event). Masters will use SCRATCH. Senior Masters will use HANDICAP.

## DRESS CODE

Tournament participants must wear proper attire during tournament events: shirts with collars or PBA bowling shirt, clean and casual slacks. No jeans OR cargo pants allowed. Worn out pants, sleeveless shirts, tank tops, collarless shirts, T-shirts, Jogging pants, walking, cutoffs or by any other name), are not permissible. Caps, hats, or headbands are not acceptable unless it is medical necessity or with permission from tournament officials. PCDBA officers have the right to make decisions they see fit.

## TEAM CAP

Total of bowler's average on a team: NO limit. This is a 4-man team event.

## RERATING

Bowlers who qualify for rerating shall bring necessary proof of tournament score sheets and his winnings for Average Modification one hour before he is scheduled to bowl.

Bowlers who have won $\$ 300$ or more in any certified or uncertified tournament before June 24th, 2024, shall be rerated. (USBC Rule 319d for example, no-tap tournament)

Bowlers shall be disqualified if they fail to submit an accurate average before the completion of the first game. (USBC Rule 319a-3)

If an entrant refuses to relate, his entry fee shall be refunded.

## 61st Annual Connie Marchione Masters RULES

The Masters is held in conjunction with the PCDBA tournament and is conducted on a scratch basis. It is open to all bowlers who enter all events.
The qualifying round shall be four games and the top 32 qualifiers shall bowl in the match play with double elimination. The top 16 bowlers shall be getting prizes.
Bowlers wanting to participate in this tournament should mark it on the entry form and include an entry fee.
The rules of USBC will govern all plays plus the following general rules:
1.The fee of $\$ 73.00$ must be paid with this entry form on or before May 10, 2024. Walk-in entries shall be accepted only after entry forms have been sent in.
1a. Late entries will be accepted up to Wednesday, June $26^{\text {th }}$. A $\$ 5.00$ walk-in fee shall be applied towards the bowler's entry fee.
2. The entry fee breakdown based on 74 entries is $\$ 32.00$ prize fund, $\$ 36.00$ bowling costs and $\$ 5.00$ tournament expense fee. A smaller entry will decrease the prize fund. The prize will be returned $100 \%$.
3. The qualifying round will be 4 games across 8 lanes, 2 bowlers to each lane. All games with scratch will be counted.
4. A total of 32 highest qualifiers will advance to the match play finals with double elimination process on Sunday. Pairings will be based on bracket system similar to college basketball.
5. Prize fund, based on 75 or more entries, shall be approximately: 1st Place, $\$ 900.00$ plus plaque. High fourgame qualifying series: $\$ 25.00$.
6. The prize fund will be based on 1 prize for every 4 entries.
7. PCDBA reserves the right to refuse entries.
8. PBA members may bowl in Masters.
9. Women with 189 or higher average can participate in The Masters as long as she has USBC membership and participate in all handicap events with PCDWBA.

## 34th Annual Don I. Miller, Sr Senior Masters RULES

1. This tournament is open to deaf Senior ( 55 and older) who enters in all events. Proof of age may be required.
2. You must pick which one event Senior Masters or Masters to participate in on entry form.
3. The fee of $\$ 50.00$ shall be included in the entry form.
4. The entry fee breakdown is $\$ 32.00$ prize fund, $\$ 15.00$ for bowling costs and $\$ 3.00$ for expenses fees.
5. The prize fund will be based on 1 prize for every 4 entries.
6. This is a HANDICAP tournament. The entrant will use his total HDCP series of his Team, Single, and Doubles events and the All-Event totals will be posted on Saturday evening.
7. The top 16 scratch All-Event scores will qualify for the one-game match play rounds on Sunday afternoon. The first round will start sometime during the Masters 3rd or 4th round's end. The 17 th qualifier shall be the alternate.
8. The entrant must pay for "ALL-EVENTS".
9. The match plays will be one game with the winner advancing to the next round and the loser goes to losers' bracket for another chance. Pairings will be based on bracket system similar to college basketball.
10. The winners will advance until two are left to roll for the Championship.
11. In case of tie games in this match play, the last two frames will be bowled to determine the winner.
12. The first place and second place shall receive a plaque from the Host.
13. The prizes will be given out based on number of entries with a ratio of 1 to 3 plus money from the Host.

NOTE: In the event of a Masters/Senior Masters Play causing a tie, both bowlers will bowl their first ball and the bowler with the higher score with this first ball will be declared a winner. If there is no higher score, both bowlers will continue bowling their first ball of the following frame until one player receives a higher score.

2. An entrant uses her highest 2022-2023 USBC Sanctioned Book average for 21 or more games.
3. If her current 2023-2024 average of 21 or more games as of FEBRUARY 1, 2024, is 10 pins or higher than her last year's average, her current average shall be used.
4. If there is an average from the past year, she shall submit a copy of the league sheet showing that 21 games have been bowled by May 10, 2024.
5. If a bowler has no average in the past, her average shall be 150 .

## HANDICAP

Handicap shall be $100 \%$ of difference of a bowler's average and 220. There shall be a maximum of ninety (90) pins per game, with a 270-pin maximum for a three-game series.

## RERATING

Bowlers who have won prizes and/or merchandise totaling \$300 or more from any one tournament between June 25, 2023, and June 25, 2024, shall report her score, position, and amount won to the tournament director at the time of check in for possible rerating. This also applies to prizes that have not yet been received. Failure to report correct averages shall forfeit tournament entry fees and all prize winnings (USBC 319d).

NOTICE: For rerating, it is the bowler's responsibility to bring all her tournament score sheets or recap sheets between June 25, 2023, and June 24,2024 , to help us rerate her fairly and accurately.

## DRESS CODE

Tournament participants must wear proper attire during tournament events. Levis or designer jeans, Capri pants and Polo sleeveless shirt are permissible if they are presentable and clean. 4) The qualifying round will be 4 games across 8 lanes. Two bowlers to each lane.

5a) A total of either 8 or 16 highest qualifiers advance to the match play finals with double elimination on Sunday.
5b) If there are less than 8 bowlers, use scratch series total of singles, doubles, and team to determine Match Play rankings.
5) All former Queens shall wear their shirts during Match Play.
6) PWBA bowlers with an average of 189 or above may not bowl in Queens. However, female bowlers with 189+ averages may participate in PCDBA's Connie Marchione Masters.
7) PCDWBA reserves the right to refuse entries for any reason.

## $27^{\text {th }}$ Annual Luci Beare Senior Queens Rules

The Luci Beare Senior Queens tournament is held in conjunction with the annual PCDWBA tournament, is conducted on a scratch basis and is open to all PCDWBA bowlers 55 and older who must bowl in all events to qualify.

1) The entry fee of $\$ 73$ shall be included with the entry form on or before May 10, 2024.

1a) Walk-in entries after March $10^{\text {th }}$ shall be accepted up to Saturday June $24^{\text {th }}$. A $\$ 5$ walk in fee shall be applied towards the bowler's entry fee.
2) She (55 and older) shall choose only ONE event: Queens or Senior Queens not both events.
3) The fee breakdown is $\$ 32$ prize fund, $\$ 36$ lineage fee, and $\$ 5$ expense fee. A larger or smaller entry will increase or decrease the prize fund. The prize fund shall be returned $100 \%$.
4) The qualifying round will be 4 games across 8 lanes. Two bowlers to each lane.
